Nine Rules of Inference

- 1. Modus Ponens (M.P.)
 - 1. $p \rightarrow q$.
 - ∴ q.
- 2. Modus Tollens (M.T.)
 - 1. $p \rightarrow q$.
 - $2. \sim q.$
 - ∴ ~p.
- 3. Hypothetical Syllogism (H.S.)
 - 1. $p \rightarrow q$.
 - 2. $q \rightarrow r$. $\therefore p \rightarrow r$.

- 4. Disjunctive Syllogism (D.S.)
 - I. $p \vee q$.
 - 2. ~p.
- 5. Constructive Dilemma (C.D.)
 - 1. $(p \rightarrow q) & (r \rightarrow s)$.
 - 2. $p \vee r$.
 - $\therefore q \vee s$.
- 6. Absorption (Abs.)

$$\frac{1. p \to q.}{\therefore p \to (p \& q).}$$

- 7. Simplification (Simp.)
 - $\frac{1. p \& q.}{\therefore p.}$
- 8. Conjunction (Conj.)
 - 1. p.
 - $\frac{2. \ q.}{\therefore \ p \& q.}$
- 9. Addition (Add.)
 - $\frac{1. p.}{\therefore p \vee q.}$

Natural Deduction

We have been constructing proofs where the steps are not given to us. To continue this process, today we now look at arguments whose proofs can be done in just three steps. Once you can do this, you will have the skills to tackle most proofs by natural deduction.

Natural Deduction

As I've said before, the real goal with natural deduction to be able to take arguments in English and verify their validity. So the following argument must first be translated into the language of logic, and then verified with natural deduction. The proof can be done in just three steps.

If Layli is present, then Majnun is happy. If Majnun is happy, then either Cala or Dirran is pleased. Cala is not pleased. Layi is present. Therefore, Dirran is pleased.
